### ***Please Read The Following***

Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) requires all Customers to agree to and execute a waiver of liability, releasing Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) from any and all liability from any damage, injury, or liability to the Customer that may be incurred during the course of the Tour and any activities or excursions included therein (collectively, the “Activities”) before undertaking or participating in said Activities.

*The Customer hereby acknowledges receipt of and agrees to the following:*

#### ***1. Release of Liability.***

In consideration for being allowed to participate in the Activity, I, the Customer, hereby release from liability and waive my right to sue Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) from any and all claims, including claims of Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) negligence, resulting in any physical injury, illness (including death) or economic loss I may suffer or which may result from my participation in this Activity, travel to and from the Activity, or any events incidental to this Activity.

## *2. Assumption of Risk.*

I am voluntarily participating in this Activity. I understand that there are risks associated with my/our participation in this Activity, such as physical and/or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability, death, property damage, or economic loss. These injuries or outcomes may arise from my/our own or other's actions, inactions, or negligence, or the condition of the Activity location(s) or facility(ies).

Nonetheless, I assume all risks of my participation in this Activity, whether known or unknown to me, including travel to and from the Activity or any events incidental to this Activity.

## *3. Indemnification.*

I agree to indemnify, defend, and hold harmless Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) from any and all claims, loss, or damage to myself, including bodily injury or damage to personal property, for any and all liabilities, and costs, including attorney fees, as a result of my participation in this Activity, including travel to and from the Activity or any events incidental to this Activity. If Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) incurs any of these types of expenses, I agree to reimburse Budapest Outdoors (Selmeczi Lilla Ágnes E.V.). I further agree to indemnify, defend, and hold harmless Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) from any and all claims, loss, or damage claimed by any third party, for bodily injury or damage to personal property, for any and all liabilities, and costs, including attorney fees as a result of any act or omission by me, the Customer, regardless of whether the act or omission is determined to be negligent, reckless, or wrongful.

## *4. Medical Treatment and Expenses.*

If I need medical treatment as a result of my participation in this Activity, travel to and from the Activity, or any events incidental to the Activity, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware that Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) does not provide health insurance for me and that I should carry my own health insurance.

In the event that I am involved in an accident or incur an injury during participation in the Activity which renders me incapacitated or unable to express a need for medical treatment, I hereby authorize Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) to procure medical attention for me on my behalf for evaluation and treatment, but in no such event shall Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) be held liable for any expenses incurred for any such treatment, and I acknowledge and agree that I shall be responsible for any and all expenses for medical treatment in such an event.

#### 5. *Severability.*

The undersigned further expressly agrees that the foregoing waiver and assumption of risk is intended to be as broad and inclusive as is permitted by the laws of Hungary, and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.

I have read this document, and I am signing it freely. I understand the legal consequences of signing this document, including (a) releasing Budapest Outdoors (Selmeczi Lilla Ágnes E.V.) from all liability, (b) waiving my right to sue Budapest Outdoors (Selmeczi Lilla Ágnes E.V.), and (c) assuming all risks of participating in this Activity, including travel to and from the Activity or any events incidental to this Activity.

I understand and agree that this Waiver of Liability shall be binding upon and inure to the benefit of the parties, their successors, assigned, and personal representatives.

To the extent that this document is being signed by a Parent/Guardian on behalf of a Customer who is a minor child, the Parent/Guardian hereby acknowledges and agrees that all provisions, agreements, acknowledgements, waivers, and authorizations asserted herein shall be that of both the Customer and the Parent/Guardian on the Customer's behalf.
